SIGN PERMIT APPLICATION**

SIGN PERMIT REQUIREMENTS

- _____ (1) **Name and address of property owner, tenant and/or sign contractor;**

- _____ (2) **Detailed drawings showing the dimensions, design, structure, sign type, illumination and location of each existing and proposed sign(s) and showing distances from property lines, roadways, right-of-way, easements and utilities;**

- _____ (3) **All signs over six (6) feet in height and over 32 square feet in sign area shall require an engineered drawing prepared by a registered professional engineer licensed to practice in the State of Mississippi. All Footings shall be inspected before concrete is poured for all freestanding signs. These signs will also require a building and inspection permit;**

- _____ (4) **See attached Charts for freestanding and building signs for the zone the sign(s) are to be located.**

The Fee Schedule for Sign Permits shall be as follows:

1. 1 square foot (SF) - 32 SF	\$25.00
2. 33 SF - 64 SF	\$50.00
3. 65 SF - 96 SF	\$75.00
4. 97 SF - 128 SF	\$100.00
5. 129 SF - 160 SF	\$125.00
6. 161 SF - 192 SF	\$150.00
7. 193 SF - 224 SF	\$175.00
8. 225 SF and above	\$200.00
